## Symposium

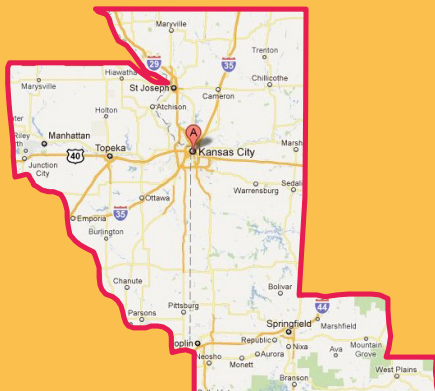
