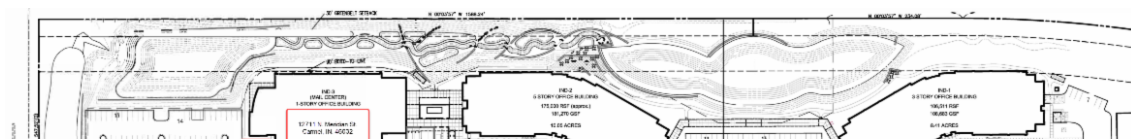
webinar! It is easier to help your clients create an account when you have done it for yourself!

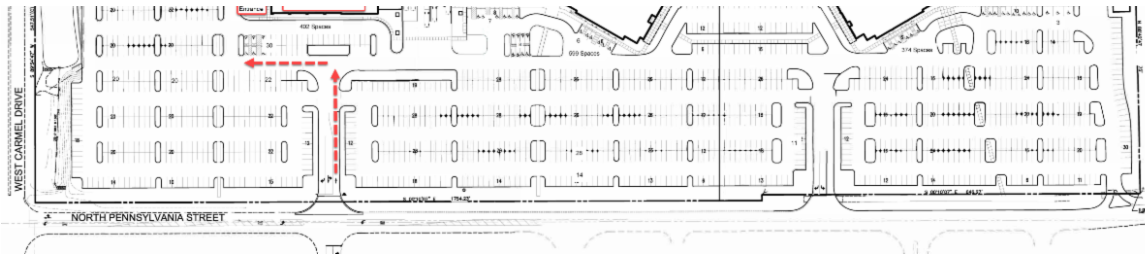
